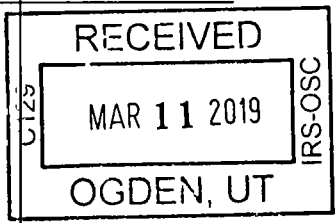



Chicas Poderosas embarked on an exciting new year with a new initiative designed to empower and support women entrepreneurs in the development of independent, digital media organizations. The New Ventures Lab (NVL), an entrepreneurial accelerator for independent media launched and drew an enthusiastic response from women journalists in Brazil, Ecuador & Peru.

The accelerator, NVL, was organized as a 17 week program with a blend of in-person sessions and virtual programming. The sessions developed the cohort as a cohesive working group, and provided skill building in the area of business development, planning, leadership, marketing, and finance.

The NVL delivered 10 women led independent media/news organizations. The teams were comprised of multi-functional professionals, many of whom had no experience in business. The accelerator was successful in supporting the business development of companies and/or new products for all teams.

Design sprints were held in key locations to increase awareness of the NVL, generating interest beyond capacity, confirming the need among these underserved communities in Brazil for these skills.

Hundreds of experienced volunteers from throughout the world contributed to the success of Chicas Poderosas NVL, the design sprints, the organizational structure and the development of the board of directors. Media experts, journalists from leading news organizations and academics offered thousands of man hours to mentor, teach, lead programming, and provide governance and direction to the organization.

Chicas Poderosas established an experienced and dedicated board of directors; the team developed the administrative and volunteer led roles for the organization and formally was incorporated in California, USA and as a 510 (c) 3 not for profit organization.
